 - A). Not to occupy more than 650 square feet should the business move to an future accessory building
 - B). No outside storage od supplies, equipment or vehicles (associated with the business)
 - C). Obtain a "sign permit" if a business related signage is to be installed.

- D). Create and maintain a safe parking and proper means of access to the business.
- E). Provide evidence (to the township) of receiving "Veteran Owned Small Business" status

- 2). The planning commission members reviewed and discussed the recommended changes to the Exeter Township Zoning Ordinance handbook raised by the township board members (from their July 2018 meeting)
 - A). Draft Hobby/Commercial Kennels;
 - "renumeration" vs. "remuneration"
 - removal of language calling for a minimum 330 feet road frontage for "Hobby' kennels. (minimum width of 200 feet already stated in zoning)
 - B). Solar Energy Systems;
 - · flexibility in requiring underground electrical cables
 - flexibility in required plant types for screening
 - C). Article 24 Zoning Administration and Enforcement
 - No additional changes recommended
