

**ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS  
OF THE STATE CONSTRUCTION CODE**

Community Name: Exeter Township, County: Monroe

**Ordinance Number 59-2014**

An Ordinance to designate an enforcing agency to discharge the responsibility of the Township of Exeter located in Monroe County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the public acts 1972, as amended.

The Township of Exeter ordains:

**Section 1. AGENCY DESIGNATED.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public acts of 1972 as amended, the Building Inspector of the Township of Exeter is hereby designated as the enforcing agency to discharge the responsibility of the Township of Exeter under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The Township of Exeter assumes responsibility for the administration and enforcement of said Act through out the corporate limits of the community adopting this ordinance.

**Section 2. CODE APPENDIX ENFORCED.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within jurisdiction of the community adopting this ordinance.

**Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.** The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Monroe County, Michigan (All Jurisdictions)" and dated 10/2/2014 and the Flood Insurance Rate Map(s) (FIRMS) panel number(s) of 26115C; 0083E, 0091E, 0093E and 0206E, dated 10/2/2014 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part Section 1612.3 of Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

**Section 4. REPEALS.** All ordinances inconsistent with the provisions of the ordinance are hereby repealed.

Section 5. PUBLICATION. This ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.
