Once a proposed (updated) section 24 is created, the planning commission members will review how the revised section 24 interacts with section 1 through 23 in the Exeter Zoning handbook.

- 2). Planning commission members reviewed zoning ordinances form various Michigan townships and current Michigan statue concerning the permitting of private / hobby kennels and personal pets. Planning commission members will study the other township ordinances and bring suggestions to the October meeting so we can start to draft a proposed ordinance.
- 3). Planning commission members discussed the proposed Master Plan update from Raisinville township. The committee members found no conflict with the current Exeter township Master Plan.
- 4). Planning commission members reviewed the Monroe County Planning Department letter (case # 200, 1-8-17-26 dated 8/9/2017) concerning the proposed Exeter Township "Solar Energy Systems" zoning ordinance. The Monroe County Planning Department felt the proposed ordinance was "... well written and that the provisions in this ordinance would give both township residents and businesses the ability to effectively utilize renewable solar energy without endangering the public's health, safety, and welfare." A public hearing will be set at a later date.
