A). Grecca Property;

- Owner has not appeared at required Court Hearing(s)
- When property is sold or transferred, beyond clean-up costs, an environmental testing will need to be completed
- Township may be responsible for some costs to clean-up
- Property can only be used as an auto recycling (scrapyard)

B). Colf Road property

- Has not filed for required Special land Use and/or re-zoning
- Planning commission has been providing owner with procedure(s) to comply with township ordinance(s)
- Ordinance enforcement is aware of the situation
- C). Former "Gas Station" located on corner of Sumpter Road and Oakville-Waltz Road
 - In process of ordering building demolished per township dangerous building ordinance.

D). No action on non-compliant accessory building (greenhouses) placed in front of main residence (home) off Ferder Road.

New Business:

- 1). ZBA Committee secretary was asked to send (via e-mail) reminders of upcoming ZBA meetings and to ask for a response if the committee member cannot attend.
- 2). Michigan Township Association (MTA) is hosting educational meeting for local ZBA members. The meeting are for update and basic understanding of the zoning appeal process and guidelines for ZBA committees. The closest meeting will be held May 15, 2023 in Frankenmuth Michigan.
