  - A). Reviewed the Exeter Township Planning Commission By-Laws (as adopted 4/4/2017) including
    - ➤ Duties and responsibilities of the Planning Commission officers and members. Requesting excused absences from scheduled meetings. Who can appoint members and length of appointments?
    - > Scheduling of monthly meetings
    - Quorum needed and procedure for cancelling or re-scheduling of monthly meetings.
  - B). Conducting a Planning Commission meeting / Public hearing
    - Set format of agenda, changes to proposed meeting agenda.
    - Set format of (previous) meeting minutes and procedure to correct meeting minutes (include as part of approving meeting minutes)
    - Allowing presentations and set time for public (residents) comment and inquiries
    - Roll of Township planner
    - Roll of Exeter Township Board member (assigned / appointed) as a liaison between the planning commission and township board
  - C). Purpose of a township planning commission
    - Any actions approved by the planning commission is considered a recommendation to the Exeter Township Board to enact at their regularly scheduled meeting. Planning Commission recommendation can be adopted, rejected or changed by the Township board
    - Current Exeter Township policy is to respond to residents' concerns or complaints (mainly in the case of "Stand-Alone" ordinances) and not to "seek out" possible violations
    - > To bring basic rules of living conditions between neighbors and the benefit of the township resident at large.
    - ➤ To receive and maintain their copy of the Exeter Township Zoning Handbook
    - > Purpose, review process, and use of the Exeter Township Master Plan

- D). Types of township ordinances
  - > Brief explanation of terms used in zoning
  - > Brief explanation of layout of Township Zoning handbook
  - > General ordinances and "Stand-Alone" ordinances
  - > How each are created and can be amended
- E). Public Hearing process, scheduling and procedures
  - > Brief explanation of terms used, permitted uses, fees collected, and documents requested from petitioner
  - > Special Land Use Requests as allowed in General Ordinances
  - > Re-zoning request for property/parcels
- F), Time for questions from planning commission members / public
- 2). Planning Commission secretary Roger Bezek gave a brief presentation and explanation of the current township ordinance that is under discussion. Revisions to Exeter Township Zoning Ordinances were reviewed from the "Proposed Zoning Ordinance Amendment" document dated 11/13/2023.
