First Public Comment:

1). Exeter Township Zoning Board of Appeal (ZBA) chairperson, Robert Strimple, thanked the Planning Commission for inviting the ZBA committee members to this joint meeting. He commented that such meeting are recommended between township committees to better

understand the current issues within the township and to improve communication between committees.

Exeter Township Zoning Board of Appeal (ZBA) chairperson, Robert Strimple, provided an overview of the roles and function of the ZBA. He stated that the ZBA role was to provide relief (known as a variance) to current township Zoning Ordinances. Request must be made to the ZBA and meet certain criteria to be considered. All discussion is conducted under the public hearing format. After hearing all comments, the ZBA is empowered to grant or deny any variances requested by a property owner. This differs from the Planning Commission who will make a recommendation to the Exeter Township Board to review, approve, modify or reject the Planning Commission recommendation(s). Rezoning request are discussed and processed through the Township Planning Commission

Chairperson Strimple stated that the ZBA meets quarterly or may conduct a special meeting if called for. All meeting are open to the public and are announced by the clerk.

Chairperson Strimple took a few question from the residents in attendance concerning the Exeter Township Master Plan

- 1).Planning Commission member reviews slight changes made to the proposed amendments to the "Keeping of Livestock" ordinances.
- 2) Discussion concerning the proposed amendment to the township ordinance concerning "Wind Energy Systems" was tabled until the April meeting to allow members time to review the changes.
